NOTICE OF RATE INCREASE

REGARDING WATER, WASTEWATER, AND STORMWATER FEE RATES AND NOTICE OF THE NEW STREET MAINTENANCE FEE RATE

Dear Town of Severance Resident,

This letter serves as a 30-day notice to inform you of the Town Council's rate increases for water, wastewater, and stormwater services that will appear on your February 2024 bill. The water rate will increase by 30%; the wastewater rate will increase by 15%; and the monthly stormwater fee will increase by \$1.00 from \$5 to \$6.

A new Street Maintenance Fee of \$15.50 per month will begin for all properties in the Town. This new fee will be restricted to the maintenance and repair of the Town's streets. This historically has been paid using the Town's General Fund balance and this new fee is required to prevent the depletion of that fund.

Town Council adopted all rates and fees in December as part of the 2024 Budget.

For accounts on Town provided water, the total of <u>all</u> the new rates is expected to increase a monthly utility bill for a typical single-family home (excluding outdoor watering or surcharges from exceeding the allotment) by an average range of \$38.45 to \$60.54 a month.

For those accounts <u>not</u> on Town provided water, the total of <u>all</u> the new rates is expected to increase the monthly utility bill an average of \$21.03 a month.

Operating costs have increased due to the price of supplies and materials and the treatment costs passed down from the North Weld County Water District. The Town Council is committed to managing those costs and staying efficient while upholding the Town's commitment to a sustainable future. These changes support the Town Council's commitment to water conservation established in the Town's adopted 2017 Municipal Water Efficiency Plan. To help promote conservation efforts, the Town of Severance will continue the water volume tier structure for customers, incentivizing those who choose to reduce their water consumption.

Utility bills are always due on the 15th of each month.

Water Service Year: The water service year is from the November billing period to the October billing period of the following year.

Allotment: The water allotment for a standard tap is 205,000 gallons per. The allotment on your account may vary due to the usage classification of your

property. Please contact Town Hall to discuss your individual account.

Water Surcharge: A water surcharge will be assessed when an account's year-to-date usage exceeds the annual water allotment. Currently, the surcharge is \$3.96

per Kgal in addition to the standard monthly usage fee. This fee is to recover the Town's cost to obtain additional water rights.

Plant Investment Surcharge:

A plant investment surcharge will be assessed when an account's year-to-date usage exceeds the plant investment allotment. Currently, the surcharge is \$3.96 per Kgal in addition to the standard monthly usage fee. This fee is to recover the Town's cost to treat and service the additional

water.

Sewer Service Year: The sewer service year is based on the average monthly water usage used during December, January, and February. Each year,

starting with the March sewer bill, monthly rates will reflect and be charged the three month average each month until the next

assessment year.

Allotment: The base allotment for a standard sewer tap is 5,000 gallons per month.

Sewer Surcharge: A sewer surcharge will be assessed when an account's usage exceeds the three-month average allotment of 5,000 gallons per month.

Currently, the surcharge is \$3.86 per Kgal in addition to the standard monthly base fee.

Street Maintenance Fee & Utility Rate Increases- FYI's

- The Street Maintenance Fee is needed to have a dedicated revenue source to complete the capital maintenance of the Town of Severance roads.
- -This includes mill and overlay and other repairs needed to preserve the long-term integrity of the road.
- -When capital maintenance is not completed, the deterioration of the roads accelerates, and repair costs increase exponentially. If delays continue, it can cost millions of dollars to reconstruct the entire road.
- -The Town roads were professionally evaluated in 2023, a rating was applied (PCI pavement condition index), and a master plan for capital maintenance was developed for the Town. The Town is currently responsible for 80 centerline miles of road. Over 1,307,437 square yards of asphalt.
- -\$800,000 (does not include inflation) is needed per year to maintain the roads per the plan developed.
- -The Town has been using General Fund Balance (savings) to pay for the capital maintenance of the roads, but it is not financially responsible to use it for an ongoing expense, nor is it sustainable. The Town uses zero-based budgeting.
- · General Fund Revenues are comprised of:
 - -37% Property Taxes
 - -31% Sales Taxes
 - -32% Other Revenue Sources
- General Fund Expenses are distributed to:
 - -Police Department (Town's largest department)
 - -Ordinary Street Maintenance potholes, street sweeping, snow plowing
 - -Parks
 - -Community Development
 - -Special Events
 - -Legislative, Admin, and Finance
- North Weld County Water District processes our water and their rates increased significantly. The Town had to raise the Town rates to cover Severance costs.
- All the fees and rate increases were discussed at the November and December Council meetings, the fall community budget open house, and then were adopted as part of the 2024 Budget. These items are discussed every year before and during budgeting for the upcoming fiscal year.
- Only a small part of your individual property tax bill goes to the Town of Severance. (Town of Severance Mill Levy is 12.635)

Unfortunately, everyone has been experiencing inflation, including the Town, and the increased utility rates are needed to cover costs and provide a reserve for emergencies.






YOUTH OF THE YEAR

Severance is proud to announce it has a new Police Chief! Kenneth Chavez assumed command of the Severance Police Department on January 1, 2024. He will be officially sworn in by Mayor Matt Fries on Tuesday, January 9, 2024, at Severance Town Hall.





Chief Chavez comes to Severance after a distinguished law enforcement career with two previous departments. He served on the Denver Police Department for forty-two years; twenty-one of which were at the rank of a command officer. From January to October 2023, he served as the Interim Chief of Police of Leadville, Colorado. This ten-month time period provided Chief Chavez with invaluable experience serving at a small-town law enforcement level which was quite different from serving in Denver, the largest city in Colorado.

Simultaneously with his law enforcement career, Chief Chavez also served thirty-six years in the Colorado Army National Guard. He served as an enlisted Soldier, Non-Commissioned Soldier, and Commissioned Officer. He commanded at the Detachment, Company, Battalion, and Brigade levels. Additionally, he served three combat tours in Afghanistan and Iraq. He retired at the rank of Colonel in 2016.

Chief Chavez has a Bachelor's Degree in Criminal Justice from Metropolitan State
University, a Masters Certificate in Homeland Security from the University of Denver, and a
Master's Degree in Strategic Studies from the U.S. Army War College. Additionally, he is a
life-time member of the Veterans of Foreign Wars (VFW), the American Legion, and has been
a member of the National Latino Peace Officers Association for twenty years.

Chief Chavez is extremely proud to have been selected to serve as the new Severance Chief of Police and looks forward to leading the Severance Police Department in serving this community with Dignity, Respect, Transparency, and Honor.

EIGHT INCHES MAX ON WEEDS AND GRASSES

Grasses and weeds must be kept at a height of <u>8" or less in yards and alleys and 9" or less in fields and undeveloped lots.</u> In Town of Severance



RUBBISH & OUTDOOR STORAGE

Properties must be maintained in a neat, tidy, and methodical manner. The accumulation of rubbish is not permitted. Rubbish includes but is not limited to items discarded or unusable or susceptible to weather as well as branches, yard waste, tires and appliances. Outdoor storage includes items not normally stored outdoors in a residential area.



ANIMAL DEFECATION AND LEASH LAWS

Any owner taking the animal upon any public way or other public property in the Town shall immediately remove or cause to be removed, and lawfully dispose of, all fecal matter left on such property by the animal. All animals shall be kept under control. No person who has assumed responsibility for an animal shall allow such animal to run at large within the Town.

TRASH SHOULD BE SECURELY STORED

Unless it's your pick-up day, your trash must be securely stored behind the front plane of the building in plastic/metal cans with tight fitting lids or tightly secured plastic bags. Take your trash to the curb no sooner than 12 hours before your scheduled pick-up day.



INOPERABLE MOTOR VEHICLES

An inoperable motor vehicle is any vehicle not displaying a current license plate and validation sticker, or is not operational due to flat tires, missing parts or damage. Inoperable vehicles may be stored on your property as long as they are screened from view. Car covers are not sufficient for screening.day.

DO NOT PARK ON YARDS

You can only park on improved areas, meaning the ground must have asphalt, concrete, rock, gravel, or other similar inorganic material with a border. Parking on all other surfaces (like grass, dirt, or bark mulch) is in violation of our local code.

SNOW REMOVAL -YOU'VE GOT 24 HOURS

Residents are required to remove snow and ice from their property's sidewalks within 24 hours after the accumulation. Remember, no letter is issued for violations, it's up to you!



THE WRONG WAY TO USE THE RIGHT-OF-WAY AND ANY EASEMENTS

Generally, a right-of-way (ROW) or easement is an area for public access (usually along roads) to host sidewalks, lightpoles, road signs, utility boxes and more. The ROW is reserved for the safe passage of motorists, bicycles, pedestrians, and stormwater. The most common items found illegally in the ROW or easement include, dumpsters, fencing, landscape materials, storage containers, basketball hoops, and any personal or commercial signage. Weeds and litter in the ROW or easement is the responsibility of the owner, agent owner, occupant or lessee of the property adjacent to the ROW or easement.

WHAT IS CODE ENFORCEMENT?

Code Enforcement is town staff, who enforce the Town's codes and ordinances. We focus on voluntary compliance and want all citizens to be able to live happily in their homes, whether a tenant or owner. Please take time to understand any violations found at your property and the necessary steps for compliance. Please visit townofseverance.org/municipal-code for code information.

HOW WE ENFORCE CODES

If an officer finds a violation or finds a complaint valid, a letter is sent to the property owner. If it's a rental property, a copy is also sent to the tenant and the property management company, if known. The letter identifies the specific violation and sets a final date to correct the problem. Remember there is no letter for snow removal violations. After the final date, an oficer will re-inspect the property. If the problem still exists, the officer may issue a civil citation and/or hire a contractor to do the work. The contractor's costs along with a municipal fee are billed to the property owner.
