A Message from Council Member Meyers

Now that the election for Mayor and Council is over...wait...huh? How could the election be over before even one ballot has been cast? I would like to explain.

The privilege of being on the Severance Town Council was originally bestowed upon me about 15 months ago upon the retirement of Trustee Bruce Florquist. Previously, I was a member of the Planning Commission here in Severance. My time spent thus far has had many highs and lows that come with what is now known as a Severance Town Council position.

I started my thought process with respect to running for Council back in February with small incidental discussions even before that. Gauging my effectiveness and drive to want to commit four years to a difficult "volunteer" position was a I tried looking at some metrics that might help to guide my direction in leading the Town of Severance. I spoke to my family. My wife, my sons, my brothers, sister and whoever else in the family that had an opinion.

I can tell you some were negative and changed as I discussed the position and what it entailed (mixed in with a little enthusiasm.) I then reached out to most of the present Council. I wanted to solicit their thoughts on my continued participation on the Council. I specifically asked the mayor for his endorsement and felt that he thought I was doing my job and should continue. I believe he was enthusiastic about continuing our efforts going forward. I did not feel any negative reasons from my colleagues not to run again. I reached out to friends who have supported me in conversation, with a positive attitude on the realities of government and occasional support for social media miscues. They were from various part of the town and felt they represented the community. I had them sign my petition and gave my thoughts on our town moving forward. I valued and continue to value their opinion and all opinions of the Severance community.

I then searched "Severance elections" and was directed to all the information that one would need to pursue a position as a Council member in Severance, Colorado....

A Message from Council Member Meyers

I picked up the packet of information and was guided as to the process that I should do to complete my petition for nomination on the Severance Town Council. I then found a manager (my wife Lynn who graciously volunteered) and started on the paperwork which included an affidavit for nomination and signatures on a petition. The requirement is ten that are residents, 18 years of age or older and registered to vote in Colorado. There is room for 20 signatures (in case of some invalidation of signatures), so I took advantage of getting 20 of my friends to sign (sorry for the many I missed). I then promptly submitted the petition and I was validated by our Town Clerk for a petition on the ballot. I waited to see if others would apply and submit nomination petitions and two others had (Brittney Vandermark, and Craig Joseph). No others applied by the deadline. I had to wait an additional week to see if anyone submitted an affidavit for" write in candidate" and that also expired. The same process repeated itself for Mayor and Mayor Matt Fries will continue to represent the Town of Severance. The board was chosen and no election would be needed.

An election where the candidates are 'elected by acclamation' is defined as an uncontested election where the number of candidates equals (or is less than) the number of seats that are vacant.

As a result, the outcome of the balloting process is totally predictable, thereby eliminating the need to go through the process of mailing and counting votes. (https://electionbuddy.com/blog/2022/10/05/whatdoes-elected-by-acclamation-mean)

I personally am proud of my work on the Severance Planning Commission and the Town Council. Please remember, all the members of this Council, including the mayor, are beholden to you, our constituents.

I have read the Constitution, it says "We the People." We ask that you participate in the process that will guide this town forward with the needs and wants of our residents as we move forward.

Congratulations to Mayor Fries on his re-election and to both Councilpersons Vandermark and Joseph on their Council assignments.



WARNING: Fire Blight

Fireblight is a destructive, highly infectious, and widespread disease caused by the bacterium Erwinia amylovora. Fireblight can be a problem in Colorado and is particularly prevalent in some counties. Fire blight attacks blossoms, leaves, shoots, branches, fruits, and roots.



As soon as fire blight is discovered, prune off infected branches 1 foot below the diseased sections and burn them to prevent further infection. Dip pruning shears into a 10% alcohol or bleach solution between each cut to avoid transmitting the disease from one branch to another.

Sec. 7-1-200. - Snow removal.

It shall be unlawful and constitute a nuisance for any person to allow snow or ice to remain on any sidewalk open to the public and abutting or adjoining the property controlled, owned or occupied by such person after twenty-four (24) hours of the last measurable snowfall or snowdrift. A notice shall state that, if the offending snow or ice is not removed from such property as prescribed by this Article on or before one (1) day from the date of such notice, the removal may be done by the Town and all costs of abatement, including the cost of inspection and all other incidental costs in connection therewith, including administrative costs, will be charged against the property, in addition to any other penalty and costs or orders that may be imposed.

EIGHT INCHES MAX ON WEEDS AND GRASSES

Grasses and weeds must be kept at a height of <u>8" or less in yards and alleys and 9" or less in fields and undeveloped lots.</u> In Town of Severance



NO NOXIOUS WEEDS

A noxious weed is a plant whose growth is restricted by law due to its destructive qualities, aggressive growth, and difficulty to eradicate. You can search for images of noxious weeds by using an internet search engine or contact us for a brochure. RUBBISH & OUTDOOR STORAGE

Properties must be maintained in a neat, tidy, and methodical manner. The accumulation of rubbish is not permitted. Rubbish includes but is not limited to items discarded or unusable or susceptible to weather as well as branches, yard waste, tires and appliances. Outdoor storage includes items not normally stored outdoors in a residential area.

TRASH SHOULD BE SECURELY STORED

Unless it's your pick-up day, your trash must be securely stored behind the front plane of the building in plastic/metal cans with tight fitting lids or tightly secured plastic bags. Take your trash to the curb no sooner than 12 hours before your scheduled pick-up day.



INOPERABLE MOTOR VEHICLES

An inoperable motor vehicle is any vehicle not displaying a current license plate and validation sticker, or is not operational due to flat tires, missing parts or damage. Inoperable vehicles may be stored on your property as long as they are screened from view. Car covers are not sufficient for screening.day.

DO NOT PARK ON YARDS

You can only park on improved areas, meaning the ground must have asphalt, concrete, rock, gravel, or other similar inorganic material with a border. Parking on all other surfaces (like grass, dirt, or bark mulch) is in violation of our local code.

SNOW REMOVAL -YOU'VE GOT 24 HOURS

Residents are required to remove snow and ice from their property's sidewalks within 24 hours after the accumulation. Remember, no letter is issued for violations, it's up to you!



THE WRONG WAY TO USE THE RIGHT-OF-WAY AND ANY EASEMENTS

Generally, a right-of-way (ROW) or easement is an area for public access (usually along roads) to host sidewalks, lightpoles, road signs, utility boxes and more. The ROW is reserved for the safe passage of motorists, bicycles, pedestrians, and stormwater. The most common items found illegally in the ROW or easement include, dumpsters, fencing, landscape materials, storage containers, basketball hoops, and any personal or commercial signage. Weeds and litter in the ROW or easement is the responsibility of the owner, agent owner, occupant or lessee of the property adjacent to the ROW or easement.

WHAT IS CODE ENFORCEMENT?

Code Enforcement is town staff, who enforce the Town's codes and ordinances. We focus on voluntary compliance and want all citizens to be able to live happily in their homes, whether a tenant or owner. Please take time to understand any violations found at your property and the necessary steps for compliance. Please visit townofseverance.org/municipal-code for code information.

HOW WE ENFORCE CODES

If an officer finds a violation or finds a complaint valid, a letter is sent to the property owner. If it's a rental property, a copy is also sent to the tenant and the property management company, if known. The letter identifies the specific violation and sets a final date to correct the problem. Remember there is no letter for snow removal violations. After the final date, an oficer will re-inspect the property. If the problem still exists, the officer may issue a civil citation and/or hire a contractor to do the work. The contractor's costs along with a municipal fee are billed to the property owner.

OCTOBER IS FIRE PREVENTION MONTH

As Fire Prevention Month approaches, Windsor Severance Fire Department reminds residents: "Cooking safety starts with YOU. Pay attention to fire prevention."



Windsor Severance Fire Rescue is teaming up with the National Fire Protection
Association (NFPA) — the official sponsor of Fire Prevention Week for more than 100 years
— to promote this year's FPW campaign, "Cooking safety starts with YOU. Pay attention to
fire prevention." The campaign works to educate everyone about simple but important
actions they can take when cooking to keep themselves and those around them safe.
According to NFPA, cooking is the leading cause of home fires and home fire injuries in the
United States. Unattended cooking is the leading cause of cooking fires and deaths.
"Year after year, cooking remains the leading cause of home fires by far, accounting for
nearly half of all U.S. home fires," said Lorraine Carli, vice president of outreach and
advocacy at NFPA. "These numbers tell us that there is still much work to do when it
comes to better educating the public about ways to stay safe when cooking."

The WSFR encourages all residents to embrace the 2023 Fire Prevention Week theme, "Cooking safety start with YOU," said Hayley Carson, Community Risk Reduction Manager. Windsor Severance Fire Rescue offers these key safety tips to help reduce the risk of a cooking fire.

- 1. Watch what you heat. Always keep a close eye on what you are cooking. Set a timer to remind you that you are cooking.
- 2. Turn pot handles toward the back of the stove. Always keep a lid nearby when cooking. If a small grease fire starts, slide the lid over the pan and turn off the burner.
- 3. Have a "kid- and pet-free zone" of at least 3 feet around the stove or grill and anywhere else hot food or drink is prepared or carried.
